Wendy spoke to some technical challenges on the website that need to be addressed. Lucine says Outreach team was not consulted. Nina says: Not new, brought to the attention of Nina earlier in FY, now is the time to do it. Wendy says she works with 12 NCs across city, doing it for 15 + years, says experience is good. Colter proposing to move ahead, but agrees it is under Outreach's purview, although funds need to be spent. Lucine says she supports this, but for precedent thinks Outreach should be included moving forward. Nina says it was because of funding deadline. Nina asks what Outreach's concerns are. James says we are well under budget. Colter says no issues with proposal, just precedent. Lucine says other opinion was the whole point, already here and in support.

E. **Discussion and possible action regarding** The Laundry Truck NPG for up to \$1200. (Angelica Naccarati) Last Wednesday of the month following the Day of Hope event. This NPG covers two months of laundry truck services through the fiscal year. The event would be marketed at the Day of Hope event. Doug pointed out that there is a high cost per load and would like the NC to look for more cost efficient ways to serve the community, such as coupons for local laundromats.

Doug also offered a washer/dryer machine that he could donate to The Hope Center that could be used at any time as opposed to just two days. He suggested that the cost of this NPG could be used to support the mechanical needs at The Hope Center to get the laundry machines plugged in.

Nina highlighted that we do not know if the Hope Center is interested in a washer/dryer available at all times. She also pointed out that this service is about restoring dignity as well as providing a service, which cannot be ignored.

Wendy stated that we are partnering with the Laundry Truck with the Hope Center due to the Hope Center's success in marketing their services in the past. She also pointed out that the Laundry Truck has a very positive reputation citywide, including prior contracts with LAUSD. She also suggested that Doug's idea of coupons or a permanent washer/dryer at the Hope Center are also viable strategies that could be considered in addition to the laundry truck.

Andoni echoed Wendy and Nina's points.

Public comment from Chad: Looking for a public program to clean our streets.

Nina directed Chad to George at CD13 who can assist with sidewalk and street cleaning.

Doug shared that because this is a TOC project, there would not be a hearing process

Doug raised concerns that he does not see a demolition permit and feels for certain that the lot was illegally demolished

Colter asked whether we can table this, whether the City would approve it anyway regardless of our decision. Nina confirmed she can table it and Doug stated that the City would be required to approve it.
